SET UP: EXHIBITORS MAY START SETTING UP AT 2:00 PM FRIDAY JULY 13, 2007. VEHICLES WILL BE ALLOWED ON GROUNDS, WEATHER PERMITTING, FOR SET UP BUT MUST BE REMOVED BY 1/2 HOUR BEFORE SHOW TIME EACH DAY. YOUR BOOTH MUST BE OPENED BOTH DAYS OF THE GATHERING DURING OPERATIONAL HOURS. **NO EXCEPTIONS!** EXHIBITORS MAY NOT BREAKDOWN THEIR BOOTH BEFORE 5:00 PM ON SUNDAY JULY 15, 2007. **YOUR SET UP AREA WILL NOT BE WITH THE CRAFTERS, BUT WITH OTHER MERCHANTS SELLING ITEMS THAT ARE NOT HANDCRAFTED.**
