

**The Gathering at French Creek 2008**  
**Food Vendor Information Sheet**  
**July 11-13, 2008**

**Please read carefully and sign the application form, indicating you have read, understand and will comply with these policies.**

Terms:

It is agreed and understood that the following rules and regulations are part of this contract. The promoter reserves the right to remove or eliminate any objectionable exhibits, person, advertisement, or any feature of action that might harm or impair the high standards of the forum and/or participants and/or attendees of the show.

Payments:

Each exhibitor must execute a contract for the right to use the space allotted. Payment is due at time of application. The canceling of your contract after June 1, 2008 will not entitle you to any refund whatsoever.

Facility:

Exhibitors will be held responsible for any damage done to the building and/or grounds by them or their employees. No nails, tacks, and/or screws shall be driven into the walls, tables, floor or woodwork of the building.

Set Up:

Exhibitors may begin setting up their display at 2:00 PM on Friday, July 11, 2008. Booths must be completed and fully operational by 5:00 PM. RAIN OR SHINE

Your booth must be opened all weekend of the Gathering during operational hours. Doors open to the public Friday at 5:00 PM, at 10:00 AM on Saturday and close at 10:00 PM or after the fireworks, Sunday open at 12 Noon and close at 5:00 PM.

No exhibitor may breakdown their booth before 5:00 PM on Sunday, July 13, 2008. Your booth must be completely removed Sunday, July 13, 2008.

Electricity is only available in designated areas for an additional charge, by prior arrangement, and on a first come, first served basis.

General:

No pets are permitted.

Liability:

Neither The Gathering at French Creek or the Union City Area School District shall be responsible for loss or damage occurring to the exhibits from any cause. Small and valuable exhibit material should be packed away each night. If insurance is desired, the exhibitor must obtain it. The exhibitor agrees to indemnify, defend, and hold harmless The Gathering at French Creek and the Union City Area School District and their respective past present and future owners, officers, agents, servants, representatives, employees, independent contractors, subsidiaries, affiliates, predecessors, assigns, and insurers (collectively referred to as "affiliates" against any and all claims for loss, injury or damage to person or property, including attorneys fees and costs arising out of the activities or exhibitor, his agent, employees, business invitees or guests. Exhibitor must provide to The Gathering at French Creek or the Union City Area School District a certificate of liability insurance. Further, the exhibitor for itself and on behalf of exhibitor's affiliates, hereby release and discharges The Gathering at French Creek, The Borough of Union City and the Union City Area School District and their respective affiliates from any and all claims, damages, suites, debts, judgments, injuries, liabilities, demand, costs, and unknown foreseen and unforeseen that have, especially those which might arise out if exhibitor's use of the space indicated on in this agreement.

Destruction of Property:

In case the premises are destroyed by fire of the elements, or by any cause, or in case of any circumstances whatsoever, including strikes, shall make it impossible to permit any exhibitor to occupy the premises, or if for any reason the show is not held as proposed, The Gathering at French Creek and the Union City Area School District not responsible for any loss of business, loss of profits, consequential or special damages or expenses of whatever nature that the exhibitor may incur and releasing all claims for damages from The Gathering at French Creek and the Union City Area School District, exhibitors shall not receive any part of the non-refundable application fee.

Licenses & Permits:

It is the exhibitor's responsibility to obtain, at their own expense, any licenses or permits which are required for operation of your trade or business during the festival. The exhibitor also agrees to pay all taxes, including sales taxes, of any nature or kind that may be required.

Pennsylvania State Sales Tax Certificate of Authority is required for all retail booths. If you do not have current tax number, you can contact the Pennsylvania Department of Revenue, 155 West 8<sup>th</sup> Street, Erie, PA 16501 or call (814) 871-4491. Your sales tax number should be available during the show if and when it is requested.
